Regular Meeting of Board of Directors Minutes

Saturday, March 18, 2017, Sunnyvale, California

1. Call to Order

The regular trimesterly meeting of the Board of Directors of SFSFC, Inc., met on Saturday, March 18, 2017, in the home of Cindy Scott, 969 Asilomar Terrace #6, Sunnyvale CA 94086-2438. The meeting was called to order at 11:10 AM Pacific Daylight Time, President David Gallaher presiding and Secretary Kevin Standlee recording. Members present (*by telephone ‡director emeritus): Sandra Childress*, David W. Others present: None. Proxies: None.

2. Previous Minutes

The minutes of the November 19, 2016 Regular Meeting and November 19, 2016 Meeting of Directors-Elect were previously approved as distributed by unanimous consent via the Board e-mail list.

3. Officer Reports

3.1. President

No report at this time.

3.2. Treasurer

Form 990/190 filings were done before Worldcon. Copies of our Form 990 (US) and 199 (California) filings for the fiscal year April 1, 2015 through March 31, 2016 are at <http://sfsfc.org/finance/2015-16%20SFSFC%20Returns.pdf>.

Ms. Scott reported on plans to close out the corporate storage locker, handing over anything of use to Worldcon 76 to them and discarding anything we no longer need, including destroying all records. With our previous free football betting tips Worldcon now 15 years behind us, the Board agreed that there is no need to retain the old records from ConJosé.

There was discussion of the specific movement of funds between the corporate and Worldcon accounts.

3.2.1. Financial Statements

The Treasurer distributed copies of General Fund financial statements (see Appendices A-B) in advance of the meeting. The corporate-only statements do not always exactly reflect reports from individual committees due to report timing.

3.3 Secretary

The corporate web site is up to date except for the November 2016 minutes, which he forgot to post. If you see something out of date, contact the Secretary

4. Standing Committee Reports

4.1. 2018 Worldcon Operating Committee

At 11:19 AM the meeting went into Committee of the Whole, Vice President David W. Clark presiding, to discuss the 2018 Worldcon Operating Committee. At 12:13 PM the Committee of the Whole rose and reported:

- The Worldcon committee submitted a written report and financial statements for both the SJ in 2018 bid (now subsumed into the Worldcon Operating Committee) and the Operating Committee (all statements are attached to these minutes)
- We currently have 1594 members. “Cancellations” are generally due to administrative errors that can only be resolved by cancelling the transaction.
- We have about \$220K of assets.
- We have resolved an issue with getting our money from RegOnline.
- Recruiting remains a challenge, but is improving. Remember that recruiting is every member’s responsibility.
- A calculation error with the San Jose CVB regarding room blocks has been corrected.
- Hotel room block will not open any earlier than September 2017; the specific date has not yet been determined.
- A revamp of the convention web site is under development.
- Appearances and Outreach are a priority at this time.
- We’re in discussion with Worldcon 75 for our traditional commitments there (Post-Hugo party).
- We continue to monitor the situation with California’s “Autograph Law,” a potential fix for the law working its way through the legislative process, and its impact upon our convention, including Art Show and Dealers’ Room.

The meeting recessed at 12:14 PM and reconvened at 12:30 PM

4.2. CostumeCon 2021 Committee

Radar reported. She will not be able to go to the 2017 CostumeCon in April Canada, but will try to cooperate with the 2018 CostumeCon and with Worldcon 76 (who will have a table at Canada) to promote the bid.

The first bid committee meeting should be sometime in June.

The election to select the site will be in 2018 in San Diego. We are currently running unopposed.

4.3. SMOFCon 2018 Committee

Bruce Farr reported. Not a lot to update since our initial report. Web site is under development. There was a discussion of the transportation from major airports to Santa Rosa.

4.2. New Zealand 2020 Committee

Randy Smith reported and submitted a written report in advance of the meeting (see Appendix C). Our only corporate concern is that SFSFC is the parent of both the Worldcon holding the 2020 site selection election and of the New Zealand in 2020 bid. Should another serious bid enter the race, we may need to revisit the decision to “adopt” the NZ 2020 committee. Once the minutes of the November 2016 meeting are online, Randy may be able to start the process of opening a bank account for the bid. The committee can use the SFSFC corporate mailbox in Sunnyvale.

5. New Business

5.1. Deputy Secretary

The Secretary appointed Cindy Scott as an Assistant Secretary for the current officer term.
